
GREEN OPERATORS "GO" PROGRAM: REBATE PROGRAM APPLICATION INSTRUCTIONS



The Green Operators (GO) program provides rebates to retrofit or replace older vehicles with more emission-efficient engines and recognizes partners for achieving goals that reduce air pollution and greenhouse gases associated with the transport of goods.

ELIGIBLE APPLICANTS

- Only GO Carriers are eligible for this rebate program.
- Carriers must provide drayage truck services to the Virginia Port Authorities Hampton Roads facilities.
- Equipment must be purchased and installed between October 1, 2008 and August 31, 2010.

GENERAL REQUIREMENTS FOR APPLICATIONS

- Incomplete applications will be returned.
- Complete applications will be reviewed on a first-come first-served rolling basis.
- Type or print legibly all items except the signature in Section V.
- Printed applications must be in black or blue ink.
- If you need space for additional information, attach additional sheets of paper. Write the owner's name on each attached sheet and attach to the application.
- Provide an itemized cost of equipment, materials, etc. with your application. Please include any product literature, specifications, brochures, etc. that would be helpful in evaluating your application.

REBATE REVIEW SCHEDULE

1. Applicant completes rebate application, signs Rebate Agreement and submits to MARAMA.

2. MARAMA confirms receipt of application within 10 business days.
3. MARAMA notifies of acceptance or denial of application within 21 business days of receipt of a complete submittal.
4. MARAMA sends copy of signed and fully executed Rebate Agreement.
